The Homeowners Association (HOA) works diligently to encourage people to keep homes looking nice, but it ultimately comes down to the pride you have for your neighborhood and yourself. With all that said, the HOA is urging everyone to do his or her part in keeping the property kept up, enhancing desirability to live in your unique community and thus increasing property values. The following basic maintenance changes the look of an entire neighborhood:

- Pressure wash house, gutters, fence, sidewalk & driveway as necessary.
- Maintain fences in an aesthetically pleasing manner.
- Pull weeds from mulch beds, rock beds & flowerbeds. Trim branches that encroach onto roofs and over sidewalks. Mow, trim and edge regularly.
- Keep trash cans, recycle bins, garbage and debris out of view. THIS MEANS THE
   <u>CANS MUST BE PLACED INSIDE YOUR GARAGE OR BEHIND AN APPROVED FENCE OR
   SHRUBS THAT ARE SHAPED AS AN (L) TO SCREEN FROM THE NEIGHBORS VIEW AS WELL.
   DO NOT LEAVE CANS IN FRONT OF YOUR GARAGE!

- Fix broken siding, fences, windows & other exterior items that need repair.
- Keep swing sets/toys out of the front yard when not in use.
- Store recreational vehicles out of view or offsite.
- Remove Christmas and Holiday lighting from yard and or home.
- SLOW DOWN AND WATCH FOR CHILDREN AND PETS IN THE NEIGHBORHOOD!
- CONTAIN YOUR PETS AND PICK UP AFTER YOUR PETS. BE MINDFUL OF THE LEASH LAW AND PLEASE BE RESPECTFUL TO YOUR NEIGHBOR'S YARDS.
- Regrettably, due to the narrowness of our streets, and the small size of many of our lots and driveways, cars parked on the street can cause considerable inconvenience to anyone entering or exiting the community. In order to facilitate a smooth flow of vehicular traffic, and to minimize risks to persons or property, it would be appreciated if <u>all</u> residents of Parkside Lakes would park their vehicles in their driveways or garages. Garages are for vehicles not boats or general storage. Please remove the aforementioned and put your vehicles in your garage and or driveway.
